TERMS AND CONDITIONS

Please note the following terms and conditions for a licence:

1. Section 207(1)(d) of the *Criminal Code (Canada)* states in part “for any person, pursuant to a licence issued by the Lieutenant Governor in Council of a Province or by such other person or authority in the Province as may be specified by the Lieutenant Governor in Council there, to conduct and manage a lottery scheme at a public place of amusement in that Province if:
 - (i) the amount or value of each prize awarded does not exceed five hundred dollars (\$500), and
 - (ii) the money or other valuable consideration paid to secure a chance to win does not exceed two dollars.”
2. Games of a type known as razzle-dazzle roll-down, dice game, three card monte, punch board or coin table are prohibited.
3. The licensee shall produce upon request of the Liquor and Gaming Authority of Manitoba’s (LGA) authorized personnel, the licence, books of accounts, records, agreements and other documents pertaining to the lottery scheme.
